Abstract

The ABSTRACT is to be in fully-justified italicized text, at the top of the left-hand column, below the author and affiliation information. Use the word "Abstract" as the title, in 12-point Times, boldface type, centered relative to the column, initially capitalized. The abstract is to be in 10point, single-spaced type. Leave two blank lines after the Abstract, then begin the main text. Look at previous crv abstracts to get a feel for style and length.

1. Introduction

Please follow the steps outlined below when submitting your manuscript to the IEEE Computer Society Press. This style guide now has several important modifications (for example, you are no longer warned against the use of sticky tape to attach your artwork to the paper), so all authors should read this new version.

1.1. Language

All manuscripts must be in English.

1.2. Dual submission

By submitting this manuscript to crv, the authors assert that it has not been previously published in substantially similar form, and no paper currently under submission to a conference contains significant overlap with this one. If you are in doubt about the amount of overlap, cite the dual submission (as described below), and argue in the body of your paper why this is a nontrivial advance. A simultaneous journal submission would be expected to have signif-048 icant additional material not in the conference paper, and should not be previously published, nor in the final accep-049 tance stages. The conference chairs reserve the right to can-050 cel submission of any paper which is found to violate these 051 052 conditions. In particular, *uncited* dual submissions will be 053 summarily dealt with.

1.3. Paper length

Consult the call for papers for page-length limits. Overlength papers will simply not be reviewed. This includes papers where the margins and formatting are deemed to have been significantly altered from those laid down by this style guide. Note that this LATEX guide already sets figure captions and references in a smaller font. The reason such papers will not be reviewed is that there is no provision for supervised revisions of manuscripts. The reviewing process cannot determine the suitability of the paper for presentation in eight pages if it is reviewed in eleven.

1.4. The ruler

The LATEX style defines a printed ruler which should be present in the version submitted for review. The ruler is provided in order that reviewers may comment on particular lines in the paper without circumlocution. If you are preparing a document using a non-LATEX document preparation system, please arrange for an equivalent ruler to appear on the final output pages. The presence or absence of the ruler should not change the appearance of any other content on the page. The camera ready copy should not contain a ruler. (LATEX users may uncomment the \crvfinalcopy command in the document preamble.) Reviewers: note that the ruler measurements do not align well with lines in the paper — this turns out to be very difficult to do well when the paper contains many figures and equations, and, when done, looks ugly. Just use fractional references (e.g. this line is 095.5), although in most cases one would expect that the approximate location will be adequate.

1.5. Mathematics

Please number all of your sections and displayed equations. It is important for readers to be able to refer to any particular equation. Just because you didn't refer to it in the text doesn't mean some future reader might not need to refer to it. It is cumbersome to have to use circumlocutions like "the equation second from the top of page 3 column 1". (Note that the ruler will not be present in the final copy, so is not an alternative to equation numbers). All au-

1.6. Blind review

Many authors misunderstand the concept of anonymiz-114 ing for blind review. Blind review does not mean that one 115 must remove citations to one's own work-in fact it is often 116 impossible to review a paper unless the previous citations are known and available.

Blind review means that you do not use the words "my" 119 or "our" when citing previous work. That is all. (But see below for techreports)

Saying "this builds on the work of Lucy Smith [1]" does 122 not say that you are Lucy Smith, it says that you are building 123 on her work. If you are Smith and Jones, do not say "as we 124 show in [7]", say "as Smith and Jones show in [7]" and at 125 the end of the paper, include reference 7 as you would any 126 other cited work. 127

Finally, you may feel you need to tell the reader that 150 151 more details can be found elsewhere, and refer them to a technical report. For conference submissions, the paper 152 153 must stand on its own, and not *require* the reviewer to go to a techreport for further details. Thus, you may say in 154 155 the body of the paper "further details may be found in [5]". 156 Then submit the techreport as additional material. Again, you may not assume the reviewers will read this material. 157

Sometimes your paper is about a problem which you 158 tested using a tool which is widely known to be restricted 159 160 to a single institution. For example, let's say it's 1969, you 161 have solved a key problem on the Apollo lander, and you

believe that the crv70 audience would like to hear about your solution. The work is a development of your celebrated 1968 paper entitled "Zero-g frobnication: How being the only people in the world with access to the Apollo lander source code makes us a wow at parties", by Zeus et al.

You can handle this paper like any other. Don't write "We show how to improve our previous work [Anonymous, 1968]. This time we tested the algorithm on a lunar lander [name of lander removed for blind review]". That would be silly, and would immediately identify the authors. Instead write the following:

We describe a system for zero-g frobnication. This system is new because it handles the following cases: A, B. Previous systems [Zeus et al. 1968] didn't handle case B properly. Ours handles it by including a foo term in the bar integral.

The proposed system was integrated with the Apollo lunar lander, and went all the way to the moon, don't you know. It displayed the following behaviours which show how well we solved cases A and B: ...

As you can see, the above text follows standard scientific convention, reads better than the first version, and does not explicitly name you as the authors. A reviewer might think it likely that the new paper was written by Zeus et al, but cannot make any decision based on that guess. He or she would have to be sure that no other authors could have been contracted to solve problem B.

2. Figures




Figure 1. This is an example of how to include an RGB image stored in a PNG file. RGB images should represented relative to the sRGB colour space.




Figure 2. Here we have converted the RGB image in Figure 1 to PDF using Photoshop (a) and compared it to the original image (b).

Figures should be typeset in the body of the text with appropriate captions. Refer to figures using the terminology Figure 1, Figure 2, etc. For subfigures, use Figure 1a, Figure 1b, etc.

Captions to figures and tables should be set in a 10-point slanted or italic Times font to distinguish them from the main body text. Captions should start with the word "Figure" or "Table" and the number as shown in the examples.

Figures can span either a single column or two columns. If they span two columns, they should under no conditions extend beyond the outer margins, or appear above the title/author block. Also, all other conventions for captions and numbering should be followed.

2.1. Illustrations, graphs, and photographs

All graphics should be centered. Please ensure that any point you wish to make is resolvable in a printed copy of the paper. Resize fonts in figures to match the font in the body text, and choose line widths which render effectively

in print. Many readers (and reviewers), even of an electronic copy, will choose to print your paper in order to read it. You cannot insist that they do otherwise, and therefore must not assume that they can zoom in to see tiny details on a graphic.

When placing figures in LATEX, it's almost always best to use \includegraphics, and to specify the figure width as a multiple of the line width as in the example below

\includegraphics[width=0.8\linewidth] {myfile.eps}

2.2. Color

Color is valuable, and will be visible to readers of the electronic copy. However ensure that, when printed on a monochrome printer, no important information is lost by the conversion to grayscale.

2.3. Miscellaneous

The space after e.g., meaning "for example", should not be a sentence-ending space. So e.g. is correct, e.g. is not. The provided $\geq q$ macro takes care of this.

When citing a multi-author paper, you may save space by using "et alia", shortened to "et al." (not "et. al." as "et" is a complete word.) However, use it only when there are three or more authors. Thus, the following is correct: " Frobnication has been trendy lately. It was introduced by Alpher [3], and subsequently developed by Alpher and Fotheringham-Smythe [1], and Alpher et al. [2]."

This is incorrect: "... subsequently developed by Alpher et al. [1] ..." because reference [1] has just two authors. If you use the \etal macro provided, then you need not worry about double periods when used at the end of a sentence as in Alpher *et al*.

For this citation style, keep multiple citations in numerical (not chronological) order, so prefer [1, 3] to [3, 1].

3. Formatting your paper

All text must be in a two-column format. The total allowable width of the text area is $6\frac{7}{8}$ inches (17.5 cm) wide by $8\frac{7}{8}$ inches (22.54 cm) high. Columns are to be $3\frac{1}{4}$ inches (8.25 cm) wide, with a $\frac{5}{16}$ inch (0.8 cm) space between them. The main title (on the first page) should begin 1.0 inch (2.54 cm) from the top edge of the page. The second and following pages should begin 1.0 inch (2.54 cm) from the top edge. On all pages, the bottom margin should be 1-1/8 inches (2.86 cm) from the bottom edge of the page for 8.5×11 -inch paper; for A4 paper, approximately 1-5/8 inches (4.13 cm) from the bottom edge of the page.

3.1. Margins and page numbering

All printed material, including text, illustrations, and charts, must be kept within a print area 6-7/8 inches (17.5 cm) wide by 8-7/8 inches (22.54 cm) high.

3.2. Type-style and fonts

Wherever Times is specified, Times Roman may also be used. If neither is available on your word processor, please use the font closest in appearance to Times to which you have access.

MAIN TITLE. Center the title 1-3/8 inches (3.49 cm) from the top edge of the first page. The title should be in Times 14-point, boldface type. Capitalize the first letter of nouns, pronouns, verbs, adjectives, and adverbs; do not capitalize articles, coordinate conjunctions, or prepositions (unless the title begins with such a word). Leave two blank lines after the title.

AUTHOR NAME(s) and AFFILIATION(s) are to be centered beneath the title and printed in Times 12-point, non-boldface type. This information is to be followed by two blank lines.

The ABSTRACT and MAIN TEXT are to be in a twocolumn format.

MAIN TEXT. Type main text in 10-point Times, singlespaced. Do NOT use double-spacing. All paragraphs should be indented 1 pica (approx. 1/6 inch or 0.422 cm). Make sure your text is fully justified—that is, flush left and flush right. Please do not place any additional blank lines between paragraphs.

Figure and table captions should be 9-point Roman type as in Figures **??** and **3**. Short captions should be centred.

Callouts should be 9-point Helvetica, non-boldface type. Initially capitalize only the first word of section titles and first-, second-, and third-order headings.

FIRST-ORDER HEADINGS. (For example, **1. Introduction**) should be Times 12-point boldface, initially capitalized, flush left, with one blank line before, and one blank line after.

SECOND-ORDER HEADINGS. (For example, **1.1. Database elements**) should be Times 11-point boldface, initially capitalized, flush left, with one blank line before, and one after. If you require a third-order heading (we discourage it), use 10-point Times, boldface, initially capitalized, flush left, preceded by one blank line, followed by a period and your text on the same line.

3.3. Footnotes

Please use footnotes¹ sparingly. Indeed, try to avoid footnotes altogether and include necessary peripheral observations in the text (within parentheses, if you prefer, as

in this sentence). If you wish to use a footnote, place it at the bottom of the column on the page on which it is referenced. Use Times 8-point type, single-spaced.

3.4. References

List and number all bibliographical references in 9-point Times, single-spaced, at the end of your paper. When referenced in the text, enclose the citation number in square brackets, for example [4]. Where appropriate, include the name(s) of editors of referenced books.

Refer to citations using a square-bracketed numeral [11]. Multiple citations should be referenced with a commaseparated list inside brackets [11,12]. Try to list such citations in numerical order. Citations are not nouns! They should be treated grammatically as parenthetical statements. Say "Consider the work of Some Author and Her Cat [22]", not "Consider the work of [22]". Do not start a sentence with a citation.

4. Final copy

You must include your signed IEEE copyright release form when you submit your finished paper. We MUST have this form before your paper can be published in the proceedings.
